

HEARING HEALTH CARE IN THE WORKPLACE

Hearing Loss is one of the most important unaddressed health conditions in America today, affecting more than 31.5 million Americans — most of whom are below retirement age.

Hearing loss can be very costly to individuals, businesses and society as a whole in the form of diminished job performance, isolation from relationships and an increase in overall health issues, such as anxiety and depression. With the increase in hearing loss, it becomes increasingly necessary that hearing health care become a workplace wellness priority.

Impact of untreated hearing loss

- Workers with untreated hearing loss take **5 times more sick days** due to severe stress than those without hearing loss.
- Misunderstandings between co-workers or management due to hearing loss **decrease job satisfaction and contribute to employee mistakes.**
- Poor communication with clients due to hearing loss can cause confusion, **diminishing client satisfaction.**
- Hearing loss is linked to a **three-fold risk of falling** among working-aged people (40 to 69). Falls and fall-related injuries cost billions in health care costs in the United States each year.
- Unaddressed hearing loss often leads to **isolation, anxiety and depression.** For employers, the estimated annual economic burden of depression, sadness, and mental illness is \$348.04 per employee. More absences from work are due to depression, sadness, and mental health issues than from any other illness.
- Hearing loss is linked to heart disease. Some researchers even hypothesize that hearing loss could be an early warning against heart disease — America's number one killer — potentially presenting an opportunity for early intervention, better outcomes, and contained health care costs. Heart disease is a huge expense for American businesses.

Testing & Treatment

Despite the growing number of employees suffering from hearing loss, far too few are seeking the hearing health care they need. Less than one-fourth of employees have had their hearing checked in the past two years; and only one in five people who could benefit from a hearing aid actually wears one.

Primary barriers to employees seeking treatment include the stigma of hearing loss, financial hardship of covering hearing aids and the general lack of awareness about the importance of prompt treatment to restore hearing before further hearing damage is done.

Fortunately when addressed early, hearing loss is largely manageable. The vast majority of people with hearing loss can benefit from hearing aids. Hearing aids will improve an employees ability to communicate effectively, hear in meetings and on the phone, understand the needs of clients, customers and coworkers. Hearing aids will also increase an employees safety, as well as, their quality of life. Eight out of ten hearing aid users say they're satisfied with the changes that have occurred in their lives specifically due to hearing aids.

Health & Wellness Initiatives

Employers can show their support of employees' overall health and wellness by providing access to hearing benefit options, covering preventive care and treatment, and by promoting education to employees on the importance of regular hearing check-ups and prompt treatment if hearing loss is detected. By taking such actions, employers can help their employees achieve a better quality of life, while preventing the health and productivity related consequences of untreated hearing loss.

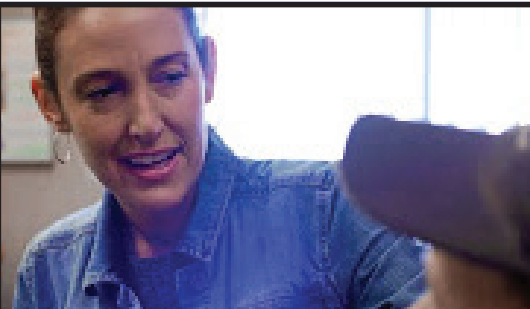
