Online shopping in general has a 30 percent return rate, and hearing aides are not a typical consumer product; they are high-tech medical devices that need to be fitted and adjusted to each person's specific hearing needs. Online, over-the-counter and big box retailers don't focus on making that personal service available.

- Follow-up care to ensure continued success and gauge any changes in hearing ability.
